**THE NINETH CONSTITUTIONAL AMENDMENT ACT OF THE  
 ZANZIBAR CONSTITUTION, 1984 AND OTHER MATTERS  
 CONNECTED THEREWITH**

ENACTED by the House of Representatives of Zanzibar.

Short title and  
Commencement.

1. This Act may be cited as the Ninth Constitutional Amendment Act, 2002 and shall come into operation immediately after being assented to by the President.

2. The provisions of the Eighth Constitutional Amendment Act (No. 2 of 2002) are hereby amended in the manner stated in sections 3 and 4 of this Act.

Amendment of  
Section 19.

3. Section 19 of the Constitution, Act No. 2 of 2002 is hereby amended by deleting a full stop in the proviso and adding the following words:-

"or if there is no opposition leader in consultation with the opposition parties".

Amendment of  
section 37.

4. Section 37 of the Eight Constitutional Amendment, Act No. 2 of 2002, is hereby amended in paragraph (c) of subsection (1) by deleting a comma at the end of that sentence and adding the following words:-



"or if there is no opposition leader in consultation with the opposition parties".
